Ganaxolone is a positive allosteric modulator of GABA<sub>A</sub> that acts on a well-characterized target in the brain known to have both anti-seizure and anti-anxiety effects. Ganaxolone is being developed in three different dose forms (IV, capsule and liquid) intended to maximize therapeutic reach to adult and pediatric patient populations in both acute and chronic care settings. Marinus is preparing to initiate a pivotal study in children with rare, CDKL5 deficiency disorder and currently conducting studies in postpartum depression and refractory status epilepticus.
